## Property Sales

August Property sales were 23, up 53.3% from 15 in August of 2010 and 53.3% higher than the 15 sales last month. August 2011 sales were at their highest level compared to August of 2010 and 2009. August YTD sales of 122 are running 5.2% ahead of last year's year-to-date sales of 116.



## Prices

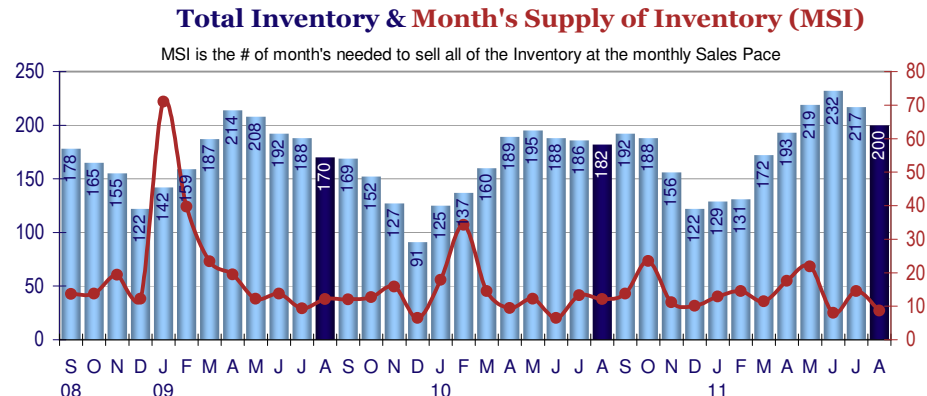
The Median Sales Price in August was \$895,000, down 21.5% from \$1,140,000 in August of 2010 and down 0.6% from \$900,000 last month. The Average Sales Price in August was \$1,203,309, up 14.5% from \$1,050,744 in August of 2010 and up 21.1% from \$993,787 last month. August 2011 ASP was at the highest level compared to August of 2010 and 2009.



## Inventory & MSI

The Total Inventory of Properties available for sale as of August was 200, down 7.8% from 217 last month and up 9.9% from 182 in August of last year. August 2011 Inventory was at its highest level compared with August of 2010 and 2009.

A comparatively lower MSI is more beneficial for sellers while a higher MSI is better for buyers. The August 2011 MSI of 8.7 months was at its lowest level compared with August of 2010 and 2009.

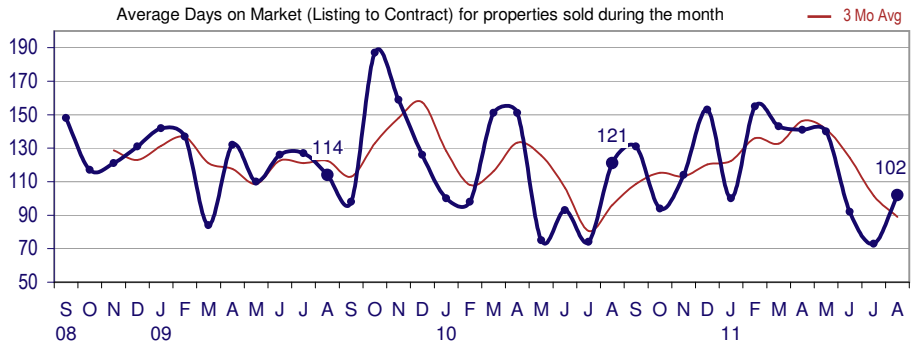

## Market Time

The average Days On Market (DOM) shows how many days the average Property is on the market before it sells. An upward trend in DOM tends to indicate a move towards more of a Buyer's market, a downward trend a move towards more of a Seller's market. The DOM for August was 102, up 39.7% from 73 days last month and down 15.7% from 121 days in August of last year. The August 2011 DOM was at its lowest level compared with August of 2010 and 2009.

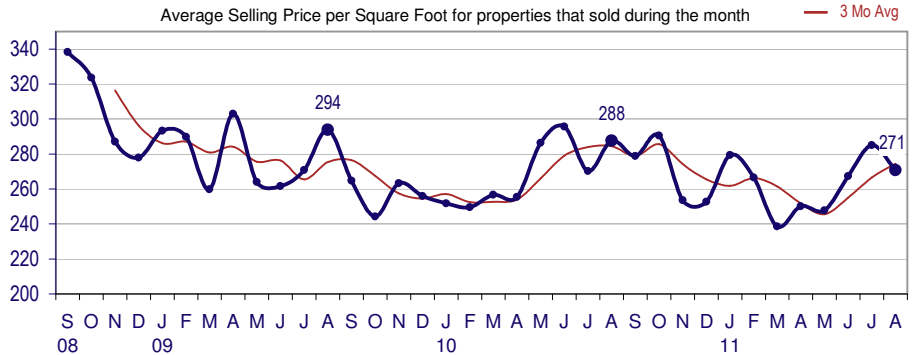
## Days On Market for Sold Properties



## Selling Price per Square Foot

The Selling Price per Square Foot is a great indicator for the direction of Property values. Since Median Sales Price and Average Sales price can be impacted by the 'mix' of high or low end Properties in the market, the selling price per square foot is a more normalized indicator on the direction of Property values. The August 2011 Selling Price per Square Foot of \$271 was down 5.0% from \$285 last month and down 5.8% from 288 in August of last year.

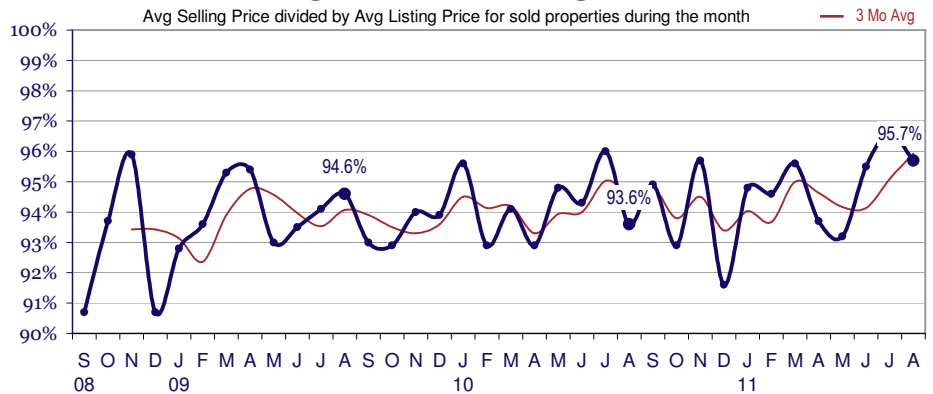
## Selling Price per Square Foot



## Selling Price vs Original Listing Price

The Selling Price vs Original Listing Price reveals the average amount that Sellers are agreeing to come down from their original list price. The lower the ratio is below 100% the more of a Buyer's market exists, a ratio at or above 100% indicates more of a Seller's market. The August 2011 Selling Price vs Original List Price of 95.7% was down from 96.6% last month and up from 93.6% in August of last year.

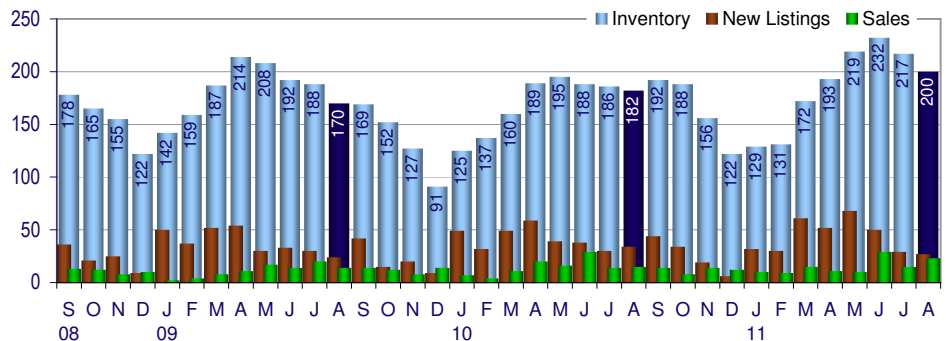
## Selling Price versus Listing Price Ratio
