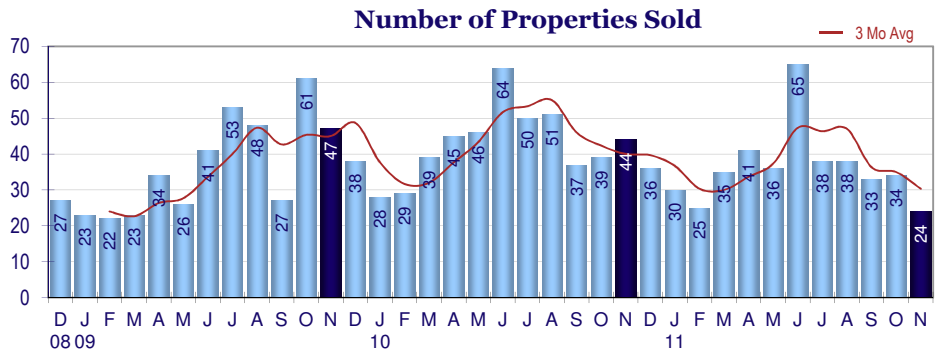

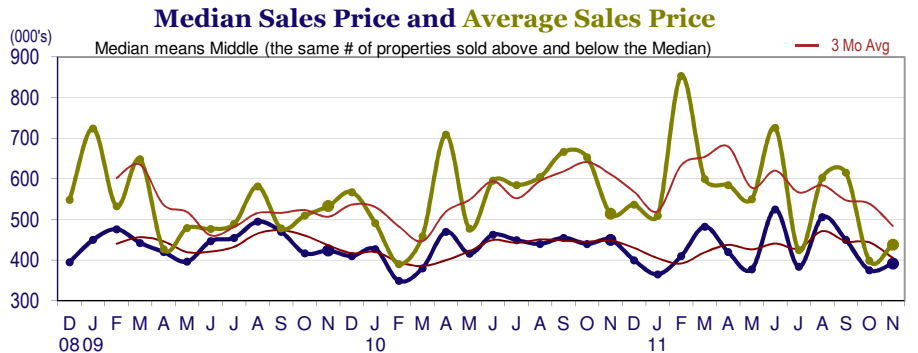
Property Sales

November Property sales were 24, down 45.5% from 44 in November of 2010 and 29.4% lower than the 34 sales last month. November 2011 sales were at their lowest level compared to November of 2010 and 2009. November YTD sales of 399 are running 15.5% behind last year's year-to-date sales of 472.



Prices

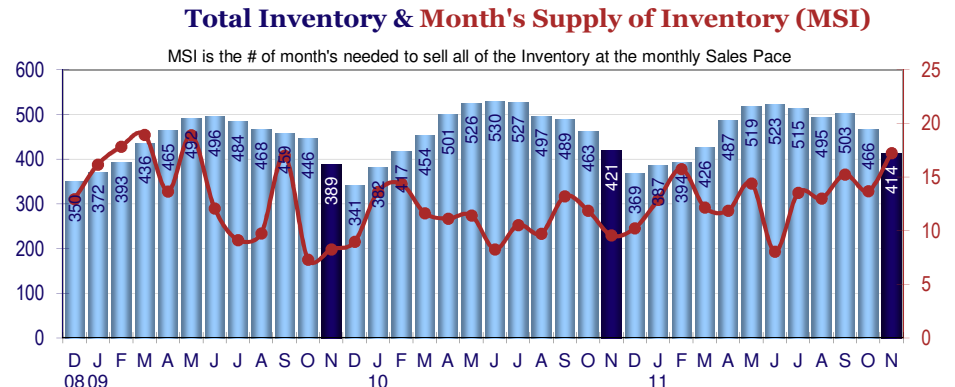
The Median Sales Price in November was \$391,250, down 13.1% from \$450,000 in November of 2010 and up 4.2% from \$375,500 last month. The Average Sales Price in November was \$438,325, down 14.8% from \$514,193 in November of 2010 and up 9.9% from \$398,971 last month. November 2011 ASP was at the lowest level compared to November of 2010 and 2009.



Inventory & MSI

The Total Inventory of Properties available for sale as of November was 414, down 11.2% from 466 last month and down 1.7% from 421 in November of last year. November 2011 Inventory was at a mid level compared with November of 2010 and 2009.

A comparatively lower MSI is more beneficial for sellers while a higher MSI is better for buyers. The November 2011 MSI of 17.3 months was at its highest level compared with November of 2010 and 2009.

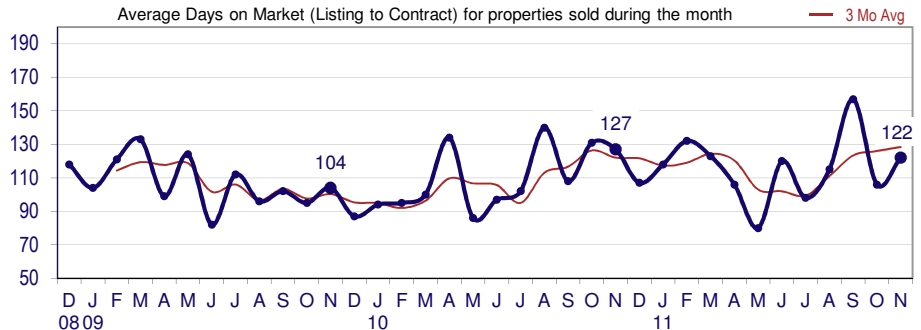

Market Time

The average Days On Market (DOM) shows how many days the average Property is on the market before it sells. An upward trend in DOM tends to indicate a move towards more of a Buyer's market, a downward trend a move towards more of a Seller's market. The DOM for November was 122, up 15.1% from 106 days last month and down 3.9% from 127 days in November of last year. The November 2011 DOM was at a mid level compared with November of 2010 and 2009.

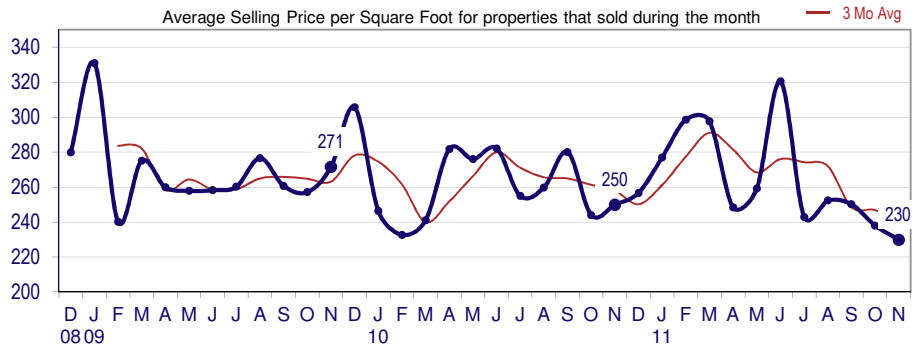
Days On Market for Sold Properties



Selling Price per Square Foot

The Selling Price per Square Foot is a great indicator for the direction of Property values. Since Median Sales Price and Average Sales price can be impacted by the 'mix' of high or low end Properties in the market, the selling price per square foot is a more normalized indicator on the direction of Property values. The November 2011 Selling Price per Square Foot of \$230 was down 3.4% from \$238 last month and down 8.0% from 250 in November of last year.

Selling Price vs Original Listing Price

The Selling Price vs Original Listing Price reveals the average amount that Sellers are agreeing to come down from their original list price. The lower the ratio is below 100% the more of a Buyer's market exists, a ratio at or above 100% indicates more of a Seller's market. The November 2011 Selling Price vs Original List Price of 94.5% was up from 93.8% last month and down from 95.1% in November of last year.

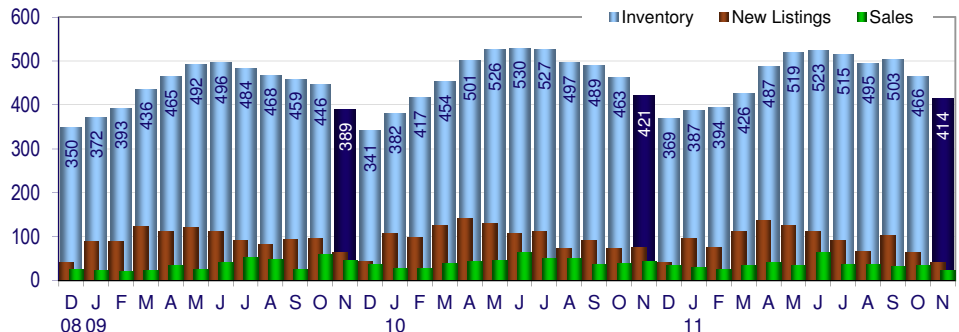
Selling Price versus Listing Price Ratio
